Competition Terms and Conditions

This competition is conducted by the Marlborough District Libraries (MDL). By entering this competition, entrants and parents/guardians are deemed to have read, understood, and accepted the following Terms and Conditions:

1. Competition

The competition is designing MDL's next Children's Library Card.

2. Entries and prize drawn

- (a) To enter the competition all entrants must complete and submit the entry form available at either Blenheim or Picton Library by 5pm on Monday 3 June 2024. Entries received after this time will not be accepted.
- (b) The competition is open to primary and intermediate school children aged 5 13. A person can enter multiple times, but each design must be made as a separate entry.
- (c) A random selection of designs will be displayed in the Picton and Blenheim Libraries on a rotating basis prior to the results being announced.
- (d) MDL will appoint a panel of 3 independent local judges (one representative from each of MDL, Marlborough District Council and Marlborough Art Gallery) who will choose the winner based on design and creativity. The judge's decision will be full and final.
- (e) The main prize to be awarded is the winners chosen design replicated on the new MDL Children's Membership Card, with artist credit on the reverse side. A \$50 Book Voucher will also be presented to the winner.
- (f) The prize draw will be made on Monday 24 June 2024. The winner will be contacted by phone or email as provided on their entry form.
- (g) If the winner does not acknowledge receipt, cannot be contacted and/or is not available in person to accept the prize within 7 days, they forfeit any claims to the prize. A runner-up will be selected at the judge's discretion.
- (h) Book prizes will be issued at the conclusion of the competition to 10 finalists selected by the judging panel and winners must claim the prize within 30 days of winning. The prizes are not redeemable for cash, are not transferable to any other person, and cannot be used in conjunction with any other offer or promotion.
- (i) Only the winner who entered the competition can be awarded the prize. No family members, friends, associates, or any other person can participate in or collect the award on the winner's behalf.
- (j) If the competition prizes are unavailable (for any reason), Marlborough District Council (MDC) and MDL reserves the right to provide the winner's a substitute prize of similar or equal value.
- (k) By accepting the prize, the winner and their guardian consent to MDC and MDL using their details, design and other material for reasonable promotional purposes including but not limited to website notices, posters, emails, online marketing activity and press.

3. Exclusions

- (a) The following persons may not enter the competition and are not eligible to win the prize:
 - (i) Anyone over the age of 13 or below the age of 5 at the time of entering the competition.
 - (ii) Anyone not resident in Marlborough at the time of the prize draw.
 - (iii) Anyone who works for MDC, its CCOs or subsidiaries; anyone who works for and in connection with MDL; and anyone who is an immediate family member or guardian or friend of the entrant.

(b) MDC and MDL reserve the right to exclude any person from participating in the competition at its sole discretion. MDC and MDL also reserve the right to refuse to award a prize to an entrant who is in breach of these Terms and Conditions, gained an unfair advantage in participating in the competition or won a prize using fraudulent means.

4. Privacy

- (a) The information provided on the entry form will only be used to contact the winners and for marketing purposes if the entrant has given consent on the entry form.
- (b) All entrants consent that, if they win the prize, MDC and MDL may use their name and photograph for publicity purposes. This may include newspaper, MDL and MDC social media, MDL website and in-house digital display boards.
- (c) Entry forms will not be returned.
- (d) All information provided by all entrants will be collected, used, stored, disclosed, and corrected in accordance with the Privacy Act 2020. All entrants have the right to access their information and request for any personal information to be collected.

5. General conditions

- (a) MDC and MDL, in its sole discretion, reserves the right to change, extend or terminate the competition at any stage, for any reason. The prize draw decision is final, and no correspondence will be entered into.
- (b) MDC and MDL are not responsible or liable for:
 - (i) Any of the prize winner's costs and expenses in accepting or using the prize;
 - (ii) Any inability to submit or complete the entry form or any delays in submitting the entry form for any reason;
 - (iii) The entrants' details on their entry forms, in particular if the winner cannot be contacted due to incorrect or out of date information or details provided;
 - (iv) Not recording, for whatever reason, an entry form into the prize draw; or
 - (v) Any loss, damage, or personal injury in connection with the prize or its use by the winner.
